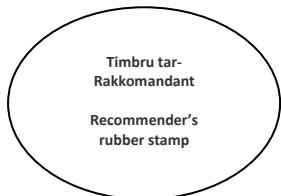

NOTI GĦALL-FORMOLA A

Jekk jogħġbok aqra sewwa dawn in-noti qabel ma tibda timla 'l-formola. Barra minn hekk, din il-formola m'għandhiex tiġi ffirmata mir-rakkomandant qabel ma tkun mimlija kollha, iffirmata u datata mill-istess applikant. Applikanti 'l fuq minn 14-il sena jridu jġibu **DEJJEM** magħhom il-Karta tal-Identità meta jissottomettu din l-applikazzjoni. L-applikanti kollha minn 6 snin il fuq jridu jiġu personalment fl-Uffiċċju tal-Passaporti biex jitteħdulhom il-fatturi biometriċi. F'każ li applikant ma jkunx jista' jattendi personalment, ikun hemm bżonn li jiġi preżentat ċertifikat mediku kif spjegat f' Nota 7. **Applikazzjonijiet mibgħuta bil-posta ma jiġux aċċettati.**

Jekk inti ċittadin/a Malti/ja, inti tista' tapplika għall-passaport Malti. Għandek timla din il-**Formola A** sabiex tkun tista' tapplika. Din l-applikazzjoni tista' tintuża minn min se japplika l-**ewwel darba**, għal min se **jgħedded il-passaport**, għal **applikazzjoni urgenti** jew għal min **intiliflu, insteraqlu jew iddistruġġa l-passaport**.

1. TIBDIL FL-ISEM, FIL-KUNJOM JEW FIL-ĠENERU

Jekk isir xi tibdil fl-isem, fil-kunjom jew fil-ġeneru (sew bi żwieġ/unjoni ċivili/separazzjoni/divorzju), ikun irid isir passaport ġdid. Tibdil f'isem aċċettat f'pajjiż barrani permezz ta' *Deed Poll*, **ma jiġix rikonoxxut f'Malta** sakemm dan it-tibdil ma jiġix insinwat fir-Reġistru Pubbliku. **Jekk persuna mwielda barra minn Malta ma tkunx irreġistrat it-twelid tiegħha fir-Reġistru Pubbliku, allura dan it-twelid u/jew żwieġ u/jew divorzju, ikun irid jiġi reġistrat fir-Reġistru Pubbliku qabel ma wiehed jissottometti l-applikazzjoni għall-passaport Malti.**

2. ĊITTADINANZA DOPPJA

Passaporti Maltin jinħarġu lil ċittadini Maltin u lil persuni li jkunu saru ċittadini Maltin permezz ta' reġistrazzjoni, naturalizzazzjoni jew ċittadinanza doppja. Jekk inti diġà għandek ċittadinanza ta' xi pajjiż ieħor, inti tista' **titlef** iċ-ċittadinanza tal-pajjiż l-ieħor kif tapplika għall-passaport Malti. 3. MINURI TAHT IT-18-IL SENA

L-applikazzjoni ta' minuri taht it-18-il sena trid tiġi pprezentata **personalment** minn xi hadd miż-żewġ ġenituri/tuturi. Trid tiġi pprezentata **DEJJEM il-Karta tal-Identità oriġinali taż-żewġ ġenituri/tuturi**. Il-passaporti ta' minuri taht it-18-il sena jingabru biss u strettament minn xi wiehed miż-żewġ ġenituri/tuturi u **tkun trid tiġi preżentata dejjem il-Karta tal-Identità**. Applikazzjonijiet mibgħuta bil-posta ma jiġux aċċettati.

Il-kunsens tal-ġenituri/tuturi **f'Taqsim 7** jrid jimtela' dejjem meta ssir applikazzjoni għall-passaport ta' persuni taht it-18-il sena. Ir-rakkomandant irid jara li l-firem f'Taqsim 7 taż-żewġ ġenituri/tuturi **jsiru quddiemu**. L-istess rakkomandant irid jimla wkoll **Taqsim 8**.

Jekk iż-żewġ ġenituri huma mejtin, it-tutor/i jrid/u jiffirma/w il-kunsens **f'Taqsim 7**. Persuna jew persuni li għandhom it-tutela tal-minuri waqt li l-ġenituri tat-tfal għadhom hajjin, iridu jipproduċu kopja tas-sentenza tal-Qorti li turi li t-tfal huma taht il-kustodja tagħhom. **Il-Karta tal-Identità taż-żewġ tuturi trid tiġi murija dejjem** meta wiehed japplika għall-passaport tat-tfal. Il-passaport irid jingabar ukoll mit-tutor/i u tkun trid tiġi dejjem ipprezentata l-Karta tal-Identità. F'kull każ, ir-rakkomandant irid jiffirma wkoll **Taqsim 8** tal-applikazzjoni, wara li jkun aċċerta ruħu mill-identità taż-żewġ tuturi.

NOTES FOR FORM A

Please read these notes carefully before you start filling the form. Furthermore, this application should not be countersigned until it is completely filled in, signed and dated by the applicant. Applicants over 14 years of age must **ALWAYS** present their Identity Card when submitting this application. Applicants aged 6 years and over must apply in person to have their biometrics captured at the Passport Office. A medical certificate must be submitted whenever an applicant cannot apply in person (vide **Note 7**). **Postal applications are not accepted.**

If you are a Maltese citizen, you are eligible to hold a Maltese passport. You should fill in the **Form A** if you wish to apply for a Maltese passport. This application form is used for submitting a **First-time passport application**, a **passport renewal**, an **urgent application** or for **replacing a lost, stolen or destroyed passport**.

The **Form A** is also used in case of persons holding Refugee Status wishing to apply for a **Convention Travel Document (Convention of the 28th July, 1951)**, for European Union foreign nationals applying for an **Emergency Travel Document** or for Third Country nationals applying for a **Document of Identity**. Further information about these travel documents is available from our Customer Desk.

As an EU Member State, Malta is required to collect biometric identifiers from the applicant in accordance with Regulation (EC) 444/2009 of the European Parliament and of the Council of 28 May 2009 amending Council Regulation (EC) No 2252/2004 on standards for security features and biometric in passports and travel documents issued by Member States.

1. CHANGE IN NAME, SURNAME OR GENDER

A new passport is required whenever there is a change in name, surname or gender (either by marriage/civil union/separation/divorce). Changes in names and/or surnames have to be registered at the Public Registry. Maltese passports are issued only on the name and/or surname as registered at the Public Registry. The full fee is to be paid in such cases. A change in name other than by marriage or adoption must be substantiated by civil status certificates issued by the Public Registry in Malta or Gozo. A change in name adopted by Deed Poll in any foreign country **will not be recognised**, unless the change is registered at the Public Registry. **If you or any other person wishing to apply for a Maltese passport is not born in Malta and/or is not registered at the Public Registry, you must first register your birth and/or your marriage and/or your divorce at the Public Registry before submitting your application for a Maltese passport.**

2. DUAL CITIZENSHIP

Maltese passports are also issued to subjects claiming Maltese citizenship through registration, naturalisation or dual nationality. If you hold the nationality or citizenship of another country, you **may lose the other nationality** when you obtain a Maltese passport. Please check with the competent authorities of the other country before submitting your application. Kindly note that the Passport Officer may demand further certificates and/or documents to establish, without doubt, your claim for Maltese nationality.

3. MINORS UNDER THE AGE OF 18: APPLYING FOR FIRST TIME APPLICATION OR PASSPORT RENEWAL

Children are no longer included in their parent's passports and must have their own separate passport. The application for a minor's passport has to be submitted **in person** by either one of the parents. **The parent calling to submit his/her son's/daughter's application must ALWAYS produce both parent's original valid Identity Cards.** Passports for persons under 18 must also be collected by a parent/tutor **upon presentation of the parent's/tutor's ID card.** Postal applications are not accepted and will not be processed by the Passport Office.

The parent's/tutor's consent on **Section 7** has to be completed for all minor applicants under 18 years of age. The recommender **must witness** both parents'/tutors' signatures before adding his/her countersignature at Section 7. The **same recommender** must also fill in and sign Section 8.

If both parents are deceased, the tutor/s **must sign** the consent at **Section 7**. Any other person claiming tutorship during the lifetime of the parents shall produce the Court Order committing the child/ren to his/her/their tutorship. The original Identity Card/s of the tutor/s must be presented when submitting the minor's application. The passport must also be collected by the tutor upon presentation of his/her ID card. The **same recommender** must also fill in and sign Section 8 of the application form.

If the minor already holds a passport, please bring it with you when applying for the new passport. This passport will be cancelled and returned back to you together with the new passport (unless restrictions apply). A minor's passport must be strictly collected by either one of the parents upon presentation of his/her ID card. A **Power of Attorney (Prokura)** either to apply for or to collect any passport is **not acceptable** and in all cases, the original ID card and receipt must always be presented.

- a) For infants aged **from birth to 5 years**, Section 7 and Section 8 must be filled in by a recommender who must also witness that both parents' signatures were done in his/her presence. **Two** identical passport photos are also needed. One of the photos must be signed and endorsed at the back by the same recommender who has signed Section 7 and Section 8. The infant is **not** required to attend the Passport Office.
- b) In the case of minors aged between **6 to 13 years**, Section 7 and Section 8 must be filled in by a recommender who must also witness that both parents' signatures were done in his/her presence. **One** passport photo is needed. The photo must be signed and endorsed at the back by the same recommender who has signed Section 7 and Section 8. The minor is required to call in person at the Passport Office to have his/her live facial biometrics captured. Children aged 12 years and over will also have their fingerprints captured.
- c) Young teenaged minors aged **14 and 15 years** must submit Section 7 and Section 8 filled in and signed by a recommender who must also witness that both parents' signatures were made in his/her presence. No passport photos are needed however the minor has to present his/her 14+ Maltese ID Card. The minor has to call in person at the Passport Office so that live facial biometrics, fingerprints and signature are taken.
- d) Teenaged minors aged **16 and 17 years** must submit Section 7 and Section 8 filled in and signed by a recommender who must also witness that both parents' signatures were made in his/her presence. No passport photos are needed however the minor has to present his/her 16+ Maltese ID Card. The minor has to call in person at the Passport Office so that live facial biometrics, fingerprints and signature are taken.

4. ADULTS 18 YEARS AND OVER: APPLYING FOR A FIRST TIME PASSPORT

If you are over 18 years of age and this is your first passport application ever, you have to complete all the details on Section 1, Section 2, Section 3 (if applicable), Section 4 (if applicable), Section 5, and Section 8. Section 8 must also be completed and signed by a recommender, who must have known you personally for at least **two years**. The recommender should be a public officer not below the grade of Principal or analogous grade, a professional person, a Minister of Religion or any other person of similar standing. Bring your valid and original ID Card when calling. Applications must be submitted in person and passports should also be collected in person by the applicant.

5. ADULTS 18 YEARS AND OVER: APPLYING FOR A PASSPORT RENEWAL

If you already hold a Maltese passport, please bring it with you when applying for a passport renewal. The old passport, cancelled by the Passport Office, will be handed back to you when you collect the new passport (provided no special restrictions apply). You have to fill in Section 1, Section 2, Section 3 (if applicable), Section 4 (if applicable), Section 5, and Section 6. No recommendation is required if you submit your expired/expiring passport. However, if your passport is lost/stolen or destroyed, Section 8 must be filled in as explained on **Note 6**. Always bring with you your original ID Card when calling. Applications must be submitted in person and passports should also be collected in person by the applicant.

6. PASSPORTS DECLARED LOST, STOLEN OR DESTROYED

If your passport is lost, stolen or destroyed, you should file in a Police report at the nearest Police Station. **Your passport application will not be processed unless you submit the Police Report.** You should also take an oath or a sworn declaration at the Passport Office, giving the full details and reasons for the passports' non-availability. A new passport replacing the lost, stolen or destroyed passport can only be issued after full investigation takes place and thus, the new replacement passport cannot be issued urgently. The new passport replacing the lost/stolen/destroyed passport may be issued valid for a restricted period.

If you are 18 years and over and you wish to apply for a new replacement passport, you have to fill in Section 1, Section 2, Section 3 (if applicable), Section 4 (if applicable), Section 5, Section 6, and Section 8. Section 8 **must be** filled in and signed by a recommender, who must have known you personally for at least **two years**. The recommender should be a public officer not below the grade of Principal or analogous grade, a professional person, a Minister of Religion or any other person of similar standing. Always bring with you your original ID Card when calling as otherwise, we will be unable to accept your passport application.

If you are applying for a minor's lost, stolen or destroyed passport, the Police Report has to be filed by one of the parents/tutors and submitted upon application at the Passport Office. Section 7 and Section 8 must be filled in and signed by a recommender who must also witness that both parents' signatures were made in his/her presence. The minor's application has to be filled in and signed as explained on **Note 3**.

7. INABILITY TO CALL IN PERSON DUE TO SICKNESS

If an applicant aged 12 years and over is **unable to call in person** to apply for the passport due to a temporary severe medical condition and provide fingerprints, the passport will be issued **with a validity period of 1 year or less**. A medical certificate must invariably be produced to sustain the applicant's claim of **severe temporary infirmity**. In such cases, a relative of the applicant must submit a declaration by a medical practitioner stating that the applicant (full name, surname and ID card number) is unable to call in person at the Passport Office due to a medical condition. On the same declaration, the medical practitioner will request the Passport Office to allow the relative (full name, surname and ID card number) to apply for and collect the applicant's passport. The relative must bring the applicant's original ID card, the applicant's passport (if applicable) and his/her original ID card. The passport will be issued valid for **1 year or less**.

An Image Capture Form, available online and from the Passport Office, must be signed by the applicant. Two passport sized photographs must also be submitted. Section 8 must be filled in and signed by a recommender. One of the photographs submitted must also be endorsed by the same recommender as explained in **Note 10**.

A passport for the full term may be issued once the individual recovers from the temporary impairment. As soon as the applicant recovers from the medical impairment, he/she will have to submit the passport for cancellation and submit the Form A duly filled in together with the relevant payment.

The Passport Officer may demand additional medical documentation and requests further evidence as deemed necessary to confirm and verify without doubt the severity of the applicant's medical condition.

8. INABILITY TO CAPTURE FINGERPRINTS

If due to a temporary impairment one is unable to provide the necessary fingerprint biometrics, the passport will be issued with a validity period of **1 year or less**. A passport for the full term may be issued once the individual recovers from the temporary impairment. In such cases, the applicant will have to submit his current passport for cancellation and submit Form A duly filled in together with the relevant payment.

Only in those cases where an applicant is permanently unable to provide his/her fingerprints due to a medical or physical condition, he/she will still be issued with a passport valid for **its full validity**. Nevertheless, such cases have to be assessed on a one-to-one basis by the Passport Officer or his/her designate. The applicant would still be required to attend at the Passport Office **in person** to have the digital photo and signature taken.

9. INABILITY TO CAPTURE BIOMETRICS DUE TO TECHNICAL ISSUES

In the unlikely event that the fingerprint capture stations fail to capture the applicant's fingerprints due to a technical problem (especially in urgent cases and for passports requested outside office hours), the Passport Office will issue the passport valid for **1 year or less** and without encoded fingerprints. A new passport for the full term may be issued once the technical issue is solved. In such cases, the applicant will have to submit his current passport for cancellation and submit the Form A duly filled in. The replacement passport will be issued with full validity and free of charge.

10. PHOTOS

In those instances (as explained above) where the applicant has to produce passport photos, these must be **recent** (not more than 3 months old), **coloured** and taken on a **white background**. The size should be **40mm x 30mm** and the face should cover at least 75% of the photo. The face has to be facing straight to the camera and must have a neutral expression. The photographs should be taken full face without hat and not wearing tinted glasses. Slot machine photographs, textured photographs, group photographs, inferior quality photographs and photographs subject to fading or sensitive to heat, **are not acceptable**. The recommender is required to endorse thus: "Certified true likeness of Mr/Ms (name and surname of applicant)" on the reverse of **one copy** and **add his/her signature** (as shown here).

The recommender has to write: Certified true likeness of: _____ (name and surname of applicant) _____ (signature of recommender)

11. COLLECTION OF PASSPORTS

Unless otherwise advised by the Passport Officer, passports are normally ready to be collected from our offices after four working days. Urgent passports may be collected after 4 hours. If passport applications are submitted through Malta's Embassies or High Commissions abroad, they take longer to be ready and one has to contact the respective Embassy for further information.

When the passport is ready for collection, applicants aged 18 years and over have to call **in person** to collect it. The applicant must bring the original ID Card and the receipt given upon application.

The applicant will be requested to have the fingerprints scanned once more to ensure that the fingerprints stored on the passport's chip are identical to the fingerprint of the person collecting the passport.

Minors aged 12 to 17 years must also call **in person** to collect their passport together with one of their parents/tutors. The parent/tutor collecting a minor's passport must always present his/her ID Card or a valid passport together with receipt of payment.

Minors aged 11 years or younger are not required to be present for the collection of their passport. In such instances, the passport must always be collected by one of the parents/tutors. The parent/tutor collecting a minor's passport must always present his/her ID Card or a valid passport together with receipt of payment.

If the fingerprints provided on collection of passport do not tally with the fingerprints encoded on the passport's chip, the passport will not be released and the matter will be investigated by the Passport Officer.

IF A PASSPORT IS NOT COLLECTED FROM THE PASSPORT OFFICE WITHIN 24 MONTHS FROM THE DATE OF APPLICATION, IT WILL BE CANCELLED AND DESTROYED WITHOUT ANY FURTHER NOTICE. IN THIS CASE, ONE WOULD HAVE TO SUBMIT A NEW APPLICATION FORM AND PAY THE FULL FEE AS APPLICABLE.

CAUTION

A Maltese citizen may hold only one valid Maltese passport at a time, except as otherwise authorised by the Director Passports. Applicants and recommenders are warned that the making of untrue statements for the purpose of procuring a passport is a criminal offence punishable by fine and/or imprisonment.
